- 2. Providing an alternative view of something claimed negative
- 3. Adding information
- 4. Praising the media when they get it right.

What is Bias?

- Factual errors
- Lack of balance
- Omission of important facts and context
- Double standards
- Editorializing in a news story



Lack of Balance

- Focusing on only one side's point of view
- Preponderance of space and/or time given to presenting a single viewpoint
- Proponents of opposing points of view given equal weight?
 - Both quoted directly? Or...
 - Is one side summarized and paraphrased while the other is expressed directly?

- In kind? Did Hamas target military targets or civilians?
- Senior Hamas "militants," not "terrorists"



Omissions

- Missing important facts and context:
 - 10-month settlement freeze
 - Previous offers of statehood
 - Egypt controls a border with Gaza
 - Thousands of rockets and missiles from Gaza
 - Palestinian media incites hatred of Jews
 - Many, many more



Double Standards

- One group is singled out for more criticism
 - Gender segregated buses in Israel condemned
 - State-sanctioned discrimination against women in Arab countries ignored
- Different terms used to describe the same phenomenon
 - Perpetrators of atrocities against Americans called "terrorists"
 - Perpetrators of atrocities against Israelis called "militants"



Editorializing

- Statements should be properly attributed, not the personal opinion of the reporter
- Loaded terms and emotional buzzwords:
 - Occupied Palestinian land
 - Illegal Jewish settlements
 - Arab East Jerusalem
 - Pre-1967 "borders"
 - Colonialism, apartheid, wall, ethnic cleansing, genocide

Israeli leader invites Abbas to the Knesset in U.N. speech





UNITED NATIONS — Israeli Minister Benjamin Netanyal an unprecedented invitatio to Palestinian President I Abbas, urging him to ad parliament.

Speaking at the U.N Jeneral Assembly, Netanyahu offered in turn to appear before the Palestinian legislature.

The Palestinians quickly rejected the invitation as a "new gimmick" designed to mask what they described as Israel's intransigence on moving forward with the Mideast peace process.

"I am ready to negotiate all final status, but one thing I will never negotiate is the right to a one and only Jewish state," Netanyahu said. Netanyahu rejects a settlement freeze, rejects the 1967 borders as the basis for talks and rejects any division of Jerusalem. He has also said he would not uproot settlements.

What Netanyahu actually said:

You see, this conflict is not about the settlements. It never was.

The conflict raged for decades before there was a single settlement...And when we uprooted all 21 settlements in Gaza and withdrew from every last inch of Gaza, we didn't get peace from Gaza – we got thousands of rockets fired at us from Gaza...for the Palestinians, the real settlements they're after are Haifa, Jaffa and Tel Aviv.

What Netanyahu actually said:

You see, this conflict is not about the settlements. It never was.

The conflict raged for decades before there was a single settlement...And when we uprooted all 21 settlements in Gaza and withdrew from every last inch of Gaza, we didn't get peace from Gaza – we got thousands of rockets fired at us from Gaza...for the Palestinians, the real settlements they're after are Haifa, Jaffa and Tel Aviv. Now mind you, the issue of settlements is a real one and it can and must be resolved in final status negotiations.

Easy as 1, 2, 3:

- 1. Just the facts, please
- 2. Good things come in small packages
- 3. Tie it with a bow



Just the Facts, Please

- Choose the main point that disturbs you the most.
- Include the heading, writer's name and the main point you are refuting:

In George Smith's op-ed piece on January 15 entitled 'Israeli Policies Hurt Palestinians,' the writer incorrectly claims that Israel practices apartheid.



- Be concise.
- Stay focused.
- Stifle emotions
- One central point is plenty:

This charge against Israel is false. Arab citizens have the right to vote. They have freedom of speech and religion. Arabs serve in the Knesset and the Supreme Court and have access to the best medical centers in the world. Apartheid is a system of racial segregation where one racial group does not have the same political, legal and economic rights as others. In fact, it is against the law in Israel to discriminate.





Tie it with a Bow

 Wrap up your letter with a last paragraph that underlines YOUR central point:

Israel's Arab neighbors practice religious and gender apartheid without any public condemnation. Only by addressing concerns where apartheid is actually practiced can the lives of the Arab people improve.

Dear Mr. President:

As you prepare to attend the United Nations General Assembly, we write to address the issue of Israeli-Palestinian negotiations. At a time of great challenges in the Middle East, we are disappointed that talks between Israelis and Palestinians remain stalled. The only way to resolve the conflicts between the two is through direct negotiations that lead to a sustainable two-state solution with a future state of Palestine living in peace and security with Israel. This outcome would provide Israel with greater security and strengthen regional stability. We remain optimistic that, under the right circumstances, Israelis and Palestinians can successfully resume productive negotiations toward this goal.

At this delicate stage the international community should both provide hope to the parties and avoid taking action that would harm the prospects for meaningful progress. Even well-intentioned initiatives at the United Nations (UN) risk locking the parties into positions that will make it more difficult to return to the negotiating table and make the compromises necessary for peace. The United States remains an indispensable trusted mediator between the parties, and we must continue to insist that neither we nor any other outsider substitute for the parties to the conflict.

Your administration has consistently upheld the longstanding U.S. policy of opposing – and if necessary vetoing – one-sided UN Security Council (UNSC) resolutions. As U.S. Ambassador to the UN, the Honorable Susan Rice summarized your Administration's position well when she exercised America's veto on a February 2011 resolution: "It is the Israelis' and Palestinians' conflict, and even the best-intentioned outsiders cannot resolve it for them. Therefore every potential action must be measured against one overriding standard: will it move the parties closer to negotiations and an agreement? Unfortunately, this draft resolution risks hardening the positions of both sides. It could encourage the parties to stay out of negotiations and, if and when they did resume, to return to the Security Council whenever they reach an impasse."

Mr. President, you also clearly stated in your September 2011 address to the General Assembly, "Peace will not come through statements and resolutions at the United Nations – if it were that easy, it would have been accomplished by now. Ultimately, it is the Israelis and the Palestinians who must live side by side. Ultimately, it is the Israelis and the Palestinians – not us — who must reach agreement on the issues that divide them.... Ultimately, peace depends upon compromise among people who must live together long after our speeches are over, long after our votes have been tallied."

We could not agree more with these statements. We urge you to continue longstanding U.S. policy and make it clear that you will veto any one-sided UNSC resolution that may be offered in the coming months. Any such resolution, whether focused on settlements or other final status issues, will ultimately make it more difficult for Israelis and Palestinians to resolve the conflict.
